EMPLOYMENT AGENCY BOND SUBMITTAL

WHEREAS, Section 9-101 of the Business Regulation Article, Annotated Code of Maryland provides that any person who, for a fee obtains, offers to obtain, or attempts to obtain employment; or provides to a client information to enable them to acquire employment: or obtains, offers to obtain, or attempts to obtain employment or an engagement in connection with an entertainment, exhibition, or performance, is considered an Employment Agency.

WHEREAS, Section 9-301 of the Business Regulation Article, Annotated Code of Maryland provides that before any such Employment Agency shall do business in the State of Maryland they shall give a bond in the penal sum of Seven Thousand Dollars (\$7,000.00) for each Agency to be operated within the State payable to the State of Maryland and conditioned upon the compliance by said applicant with the provision of Title 9 of the Business Regulation Article and the payment by such applicant of all damages occasioned to any person by reason of any misstatement, misrepresentation, fraud, or deceit forbidden by said subtitle of the part of such applicant or of his agents or employees.
