## **Continuing Education Review**

### **MSTAP**

Mr. Michael Kohler of the Maryland Society of Accounting and Tax Professionals addressed the Board and presented MSATP's concerns that there is not an official reporting mechanism for registered tax preparers who encounter violations of the Board's statue and regulations or State or Federal tax law when reviewing clients' tax returns prepared by other individuals. The Board discussed its complaint process and noted that the primary difficulty for the Board is getting releases from taxpayers to be able to review the actual tax returns in question. The Board affirmed its willingness to pursue as far as possible any complaints filed, and also suggested that registered preparers can also contact the IRS or the Office of the Comptroller if they believe an individual has violated State or Federal tax law.
