#### Call to Order:

#### **Approval of Minutes:**

#### Trampoline Park Inspection

Mr. Finecey made the case for the adoption of ASTM F2970-22 to address the inspection of trampoline parks. He noted that the code does not currently allow for inspection of trampolines but trampolines are by definition an amusement ride.

Board members and industry representatives discussed the need to better define two aspects of ASTM F2970-22:

- 1. Clearly define "define major modification better than what is written in ASTM F2970-22' "8.1 Major Modification- As specified in Terminology F747.
  - 2. Request that pre-existing trampoline parks be "grandfathered" in that aren't built completely to ASTM F2970-22 based on year built.

Roy Shaw made a motion to allow the Division of Labor and Industry and the Commissioner to establish a workgroup to study the definition of major modification to a trampoline amusement attraction. The motion was seconded by Karen Nicklas. The workgroup will address the two aspects noted above.

#### **Other Business:**

The Board decided on the following meeting dates for 2024. The summer meeting will be in Ocean City on June 20, 2024, and includes a tour of Jolly Rogers. The fall meeting will take place in the Hagerstown/Frederick area on December 12, 2024.

Commissioner Virk thanked all the board members for their diligent efforts toward amusement ride safety.

Dave Dearborn informed the board that a public inquiry was submitted for Dining in the Sky. There will be further investigation.
