### PILOT-IN-TRAINING (PIT) SELECTION COMMITTEE REPORT

Chair Steeves announced that Mr. Derby accepted the position as the Chair of the PIT Selection Committee to supersede him for this year's selection process. Capt. Horowitz reported that there were 32 PIT candidates chosen for interviews. The Committee will offer two (2) interview dates in May, one (1) in July, and lastly one (1) in August 2024. He also mentioned that all the information was already forwarded to Mr. Thomas for notification.

### **QUALIFICATION COMMITTEE REPORT**

Capt. Nielsen reported the following pilots for license upgrade on behalf of the Qualification Committee:

Capt. Nielsen stated that Capt. John Traut's 36' Limited license will start sometime in June when he finishes his 36 roundtrips additional training with Senior Pilots and 19 days that he did not finish during his initial training.
